History of the company

- ▣ “Mistral – TSS” was established in 1990 with a registered seat of office in the town of Kozloduy, Bulgaria.
- ▣ Founder of the company – Mr. Velko Stamenov. Mr. Stamenov has occupied key positions in NPP Kozloduy in the 1970s and 1980s. He was among the people who built up the nuclear power plant near Kozloduy.
- ▣ These days “Mistral – TSS” is owned and managed by his son Mr. Mihail Stoyanov and his granddaughter Ms. Viliana Stoyanova.

Subject of business activity

- ▣ “Mistral – TSS” is a leading construction company, as Mr. Mihail Stoyanov is also chairing the Supervisory board of the Bulgarian Construction Chamber in Vratsa region.
- ▣ The company has a significant experience in the overall construction of administrative, residential and commercial buildings, as well as industrial facilities.
- ▣ Beside the rough construction, “Mistral – TSS” has also specialized in infrastructure building, incl. electricity, roads, water and sewerage systems.
- ▣ The company also distributes construction materials as a representative of international and local brands.

Staff and tangible assets

- ▣ For the time being “Mistral – TSS” has about 300 employees, incl. engineers and other technical personnel (constructors, fitters, installers etc.).
- ▣ The company maintains its own production, technological and storage bases both in the towns Belene and Kozloduy. In the municipality of Belene “Mistral – TTS” owns the only concrete base, incl. a fleet of dumpcrete trucks.
- ▣ The company is stocked with a full technical equipment and has a well trained personnel at its disposal.

- ▣ “Mistral – TSS” is a certified subcontractor of Atomstroyexport.
- ▣ The company has a profound experience and unblemished reputation over the past 20 years. Moreover, it has an invaluable background in a harsh business environment. Our goal has never been survival, but a steady growth.
- ▣ “Mistral – TSS” is a family company of three generations. There is a certain degree of continuity and traditions both in the construction business and the energy sector.
- ▣ “Mistral – TSS” is NOT a limited liability company as to the Bulgarian legislations, i.e. the partners are personally responsible for the liabilities of the company. This has always been an additional guarantee for the banks and other partners we work with.

Scope of activity

- ▣ Currently, “Mistral – TSS” is concentrating its business activities mainly in the area of Belene and the project for a second nuclear power plant in Bulgaria.
- ▣ Historically, the company has been operating primarily in the North West of Bulgaria (Vratsa and Montana regions), in the Central North (Pleven) and in the capital city of Sofia.
